Methods and materials for containment and cleaning up

Precautions for safe handling

- Conditions for safe storage, including any incompatibilities** : Store in accordance with local regulations. Lifetime mouse skin painting studies indicated that white mineral oils are not mutagenic or carcinogenic. Effects from single and short-term repeated exposures to high concentrations of mineral oil mists well above applicable workplace exposure levels include lung inflammatory reaction, lipid granuloma formation and lipid pneumonia. In acute and sub-acute studies involving exposures to lower concentrations of mineral oil mists at or near current work place exposure levels produced no significant toxicological effects. In long term studies (up to two years) no carcinogenic effects have been reported in any animal species tested.
