- Appropriate engineering controls** : Good general ventilation should be sufficient to control worker exposure to airborne contaminants.

**Distillates (petroleum), hydrotreated heavy paraffinic:** Mineral oil mists derived from highly refined oils are reported to have low acute and sub-acute toxicities in animals. Effects from single and short-term repeated exposures to high concentrations of mineral oil mists well above applicable workplace exposure levels include lung inflammatory reaction, lipoid granuloma formation and lipoid pneumonia.
