#### **Prevention**

# Section 5. Fire-fighting measures

#### **Extinguishing media**

Suitable extinguishing media

### Specific hazards arising from the chemical

If sufficient charge is accumulated, ignition of flammable mixtures can occur. To reduce potential for static discharge, use proper bonding and grounding procedures. # Section 6. Accidental release measures

### Large spill

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. #### **Precautions for safe handling**

# Appropriate engineering controls
